NOT BORN A DEMOCRACY: CONSTITUTIONAL PRECONDITIONS

MARTHA MINOW*

ABSTRACT

Beneath growing perceptions of constitutional crisis and democratic fragility in the United States lies a fundamental conundrum. Critical preconditions for effective self-government are either weak or missing in action, and our constitutional system, at least for now, stands in the way of actions to strengthen or build those preconditions. This Article focuses on three essential predicates for constitutional democracy that face jeopardy: education, reliable news, and security against lethal violence. As basic as these elements may be, repeated efforts to secure a federal constitutional right to education have failed in the courts. Because of a confluence of legal, technological, and economic problems, once vibrant newspapers and magazines in the United States are rapidly shrinking or closing. Deaths and injuries due to guns mount yearly, and courts block reform efforts to advance human safety. Why are these meaningful preconditions for self-government? Why are even earnest efforts at fortifying them blocked? And what are promising ways forward?

INTRODUCTION

When he was Secretary-General of the United Nations, Kofi Annan said: "[N]o nation is born a democracy." Certainly, no nation is born a constitutional democracy. Historically, societies embracing the ideal started far from it. Ancient Athens, ancient Rome, and the early government of the United States confined self-government to an exclusive elite depending on the coerced labor of other human beings. Many so-called constitutional democracies have engaged in empire-building predicated on conquest and social hierarchy, violating their alleged values. Even the much-celebrated Scandinavian nations in recent years have considered betraying their ideals when it comes to immigrants and other "others."

It has become common to note how constitutional democracies around the globe are in real trouble. Seemingly functioning democratic systems have collapsed.⁴ Even nations proud of their constitutions and democratic institutions risk erosion and disintegration.⁵ Current elected leaders in Hungary, Venezuela, the Philippines, and Turkey engage in authoritarian practices "to dominate not only the executive and legislative branches, but also the

media, the judiciary, civil society," security forces, and the economy. ⁶ Curbing individual rights in the name of national security, manipulating mass media and elections, demonizing critics, spreading corruption—these are the elements identified by Professor Timothy Snyder in his historical lessons on tyranny. ⁷ Some writers note eerie parallels between Hitler in Germany and Mussolini in Italy with Orban in Hungary. ⁸ Here in the United States, some current public figures seem to read from the same playbook: Blame others, attack immigrants, foment social divisions, and demonize any source of authority other than themselves. ⁹ Our recently elected president has authorized assaults on both the administrative state and guardrails on presidential power while attacking immigrants and deploying law enforcement against those believed to have ever challenged him. ¹⁰

The problem for constitutional democracies is not the occasional emergence of demagogues. ¹¹ Every age produces them. The deeper challenge is the erosion of belief and commitment to the practices and institutions that provide accountability and that grow a sense of shared fates for societies embarked on self-governance. ¹² As individual leaders and their supporters accumulate personal power and wealth, they deliberately, or in effect, hollow out democratic institutions and constitutional values. Modern authoritarians in erstwhile democracies cast doubt on or even hijack elections and sources of reliable information, appealing to the psychological and economic discontent of the people without in fact doing much for them. ¹³

"Democratic deterioration" is detected now in parts of Europe, South America, India, and the United States. ¹⁴ More than sixty nations—involving 49 percent of the world's population—went to electoral polls in 2024 amid potential floods of misinformation and disinformation. ¹⁵ Incumbents and traditional parties faced deep challenges as right-wing groups gained support, reflecting widespread dissatisfaction with economic and social trends. ¹⁶ The United States took the extraordinary step of punishing allies of Venezuela's

Nicolás Maduro for human rights violations and obstructing voting in the disputed presidential election there. ¹⁷

Even as the forms of democratic elections and courts continue to exist, they elicit declining amounts of confidence. Perhaps the deepest challenge for constitutional democracies comes with the rising number of people around the world who believe this form of government is not working. ¹⁸ Understanding these trends and the reasons for them is critical. A prominent poll reported that among eighteen- to twenty-nine-year-olds in the United States, only 57 percent said that keeping the nation a democracy is very important. ¹⁹ Those coming of age in recent years may have seen democratic societies fumbling or paralyzed during the COVID-19 pandemic, periods of economic instability and inequality, refugee and immigration crises, environmental catastrophes inefficacy, global wars, and elections flooded with dark money and allegations of corruption. ²⁰ No wonder disillusionment and skepticism about

democracy is abound. Yet amid polarization over many issues, even the meaning of "democracy-facing threats" signaled contrasting concerns. Some prominent leaders, notably in technology and finance companies, expressly criticize democracy as inefficient and passé. 22

Hence, lying behind disagreements over any particular environmental, economic, social, or foreign policies are sharp disputes over the actual value of democratic governance and constitutional principles. Those divisions animate willingness to support violent actions against opponents, including election officials, election workers, and judges.²³ The United States is only one of many ostensible constitutional democracies across the globe manifesting such

sharp divisions.²⁴ I worry that the actual ingredients of effective self-government are either weak or missing in action in the United States. And in palpable ways—including binding Supreme Court decisions—the American constitutional system stands in the way of actions to strengthen or build those preconditions.

Even ardent supporters of constitutional democracy emphasize the daunting obstacles to make it work at any time and in any place. Evidence of needed preconditions can be found in scholarly and popular writings about ideals and practices of constitutional democracy. Defenders agree that the basic predicates of constitutional democracy include: (1) acceptance of election results to ensure peaceful transitions after the voting is done—and the reciprocity such acceptance requires; (2) peaceful co-existence even amid social, political, and religious differences sufficient to support inclusive political debate among people with different affiliations and views; (3) adequate capacity and stability for families or other

social groups providing care for children and the elderly as both ingredients and goals of self-governance and social continuity;²⁸ (4) freedom for individuals to form and maintain private associations, organizations, and religions as training grounds for self-governance as well as bulwarks of freedom against the power of the state;²⁹ (5) genuine promise to eliminate permanent social castes, including persistent inequalities along economic, racial, ethnic, or religious lines;³⁰ and (6) effective vigilance against entrenchment of power and corruption that blocks criticism and change, preventing reliable means for self-governance and rights for all.³¹ Each of these predicates deserves more than the brief mention I offer in this Article.

I focus here on three constituent ingredients—three predicates—that seem both fundamental to not only the creation but also to the durability of constitutional democracy, and yet in the United States mid-2025 seem caught in intractable difficulties: (1) education as preparation for citizenship, (2) robust and sustainable sources of news, and (3) human security against lethal violence, including gun violence. The work of self-governance over time depends on participants informed, committed, and secure enough to participate. Yet ensuring education, maintaining a robust and substantial press, and assuring safety from violence face barriers across the United States. The roadblocks, in no small part, come from judicial

interpretations of the Constitution. Courts have repeatedly rebuffed efforts to secure a federal constitutional right to education even as individual schools fail to provide even minimally effective instruction and nationwide scores on tests of knowledge reveal stark failures. Constitutional understandings seem to chill responses to the confluence of legal, technological, and financial difficulties rapidly shrinking or shutting down vibrant newspapers, magazines, and other media in the United States.

On security, violence and the risk of violence jeopardize any kind of society. Death threats against judges and actual violence against leaders reflect high levels of distrust and polarization as well as desensitization to violence and its effects. The levels of lethal gun violence make the United States exceptional. The gap between public opinion and what the courts allow could send confidence in the system of government itself into a death spiral. Since 2020, gun violence has been a leading cause of death for the nation's youth as well as a major source of injuries. The U.S. Surgeon General under President Biden identified firearm violence as a critical public

health crisis.³⁵ Ultimately, in jeopardy here is faith in the system of government as majorities favor restrictions on firearms, but the courts, relying on the U.S. Constitution, block many restrictions on sales and uses of guns.³⁶ Judicial interpretations of the Second Amendment "right to bear arms" create confusion and drain confidence in the government and in public safety.³⁷

Constitutional democracy aims to produce what it also presumes: equal respect for self-governing members of society. ³⁸ Our Constitution announces rights against the government. It enables judicial enforcement, authorizes elections, and divides governmental power to check tyranny. It imagines a virtuous circle, checking power while enabling self-government and individual rights. These rights and structures in the eyes of many are not working to guard against entrenched power and do not enable effective self-government. If preconditions for these structures and rights are frail or absent, what can be done? The crises in education, news, and guns illuminate the obstacles but also, I hope, prompt ideas about potential ways forward to strengthen constitutional democracy.

I. EDUCATION

Let us start with education. A constitutional democracy requires a critical mass of people who participate in politics and believe in (1) advancing self-governance; (2) individual rights; and (3) restraining oppressive power. Each new generation needs opportunities to

learn and chances to identify leaders who will advance general welfare and adhere to the Constitution. Education should cultivate literacy, critical thinking, and both knowledge of and appreciation for civic infrastructure.³⁹ For a constitutional democracy to remain viable, successive generations need to develop skills and attitudes critical to self-governance. Those skills and dispositions include knowing how to access and assess information and, as two experts put it, having "appreciation of the responsibilities of citizenship, interest in the welfare of others, a sense of personal and collective agency, and capacity to engage in civil disagreement while maintaining civic friendship."40 Education does and must take place in homes, neighborhoods, associations, religious settings, mass media, cultural events, service through military branches, juries, and communities.41 But collective investment in education around the world has turned to and will continue to focus on schooling supported by the government.⁴²

Education is probably still the single most important thing that underlies and ensures democracy. Most of the literature shows that in any place, at any time,

other democratic constitutions, the U.S. Constitution has no textual reference to education or schooling.⁴⁴ Chronic underfunding characterizes American schools as a whole, with inequities between and within districts effectively mirroring and exacerbating economic and racially marked disparities.⁴⁵ Despite excellence in individual schools and districts generally, the United States ranked nineteenth in science and thirtieth in math among the thirty-five members of the Organization for Economic Cooperation and Development.⁴⁶

Inequities in educational resources follow zip code and students' family income. Unequal resources also correlate with race.⁴⁷ With only two exceptions, public schooling across the United States is largely funded by local property taxes, a policy that bakes in inequalities.⁴⁸ Disparities in per-pupil expenditures also mean stark

differences in the availability of rigorous courses, quality instruction, and stable teaching staff. ⁴⁹ Contributing to the increasing inequality in educational opportunities within the United States is the large gulf between the ultra-wealthy—who often choose private schools—and everyone else. ⁵⁰

Education specifically keyed to preparing individuals to engage in voting and public governance is also available to some students but not for many others. Effective teaching about history and civics helps students gain knowledge and confidence to engage in political activities, but many American schools do not offer such opportunities. Only one in three Americans could pass the nation's citizenship test for naturalizing immigrants. Without basic understanding of the system, how can individuals know how to participate in the self-governing process? Educational shortfalls curb people's abilities to assess policies and to weigh personal and

societal interests. Urban, rural, and suburban low-income communities in particular lack sufficient resources for their schools.⁵³ President Trump has called for the establishment of a commission and programming to promote patriotism and celebration of the American founding and "a clear examination of how the United States has admirably grown closer to its noble principles throughout its history," without directing any support for the tools of actual civic engagement.⁵⁴

Massachusetts mandated public schooling in 1647 and inspired similar efforts in other parts of the colonies, and ultimately in the United States. ⁵⁵ Leading contributors to the U.S. Constitution advocated for governmental support of education. ⁵⁶ The Framers of the U.S. Constitution did not, however, specify any support for schools or school finance and instead left the field to private actions and to state and local government.

As originally designed, the U.S. Constitution did not provide for broad self-government; voting was reserved for white men with wealth and access to education, although anyone could participate in town halls and protests.⁵⁷ The founding fathers feared demagogues and tried to guard against self-aggrandizing individuals who would destroy the checks and balances of the system.⁵⁸

Concentrating power in the hands of elites was one answer, though John Adams worried about this feature of the original plan. ⁵⁹ The Constitution arranged for senators to be elected through state legislatures until the ratification of the Seventeenth Amendment in 1913 established direct voter election of senators. The Senate's equal representation of small and big states, presidential elections determined by an Electoral College tilted toward the states with small populations, state laws producing winner-take-all selection of members of the Electoral College, and internal congressional rules such as the filibuster compound antidemocratic features of the system. ⁶⁰

Even so, many of the drafters of the Constitution expressed keen commitment to broad education to prepare people for self-government. As Professor Derek Black has documented, two years before the Constitutional Convention, the Northwest Ordinance laid out plans for schools in the territories destined to become new states and asserted that "religion, morality, and knowledge, being necessary to good government and the happiness of mankind, schools and the means of education shall forever be encouraged." George Washington and Thomas Jefferson both stressed the vital importance of education to consent of the governed and to self-government. 62

A generation after the founding, Horace Mann led a movement starting in the 1830s pressing successfully for free and universal "common schools." Mann emphasized that schooling would not

only help economic and social advancement, but also support the capacities of people needed by the nation's political structure. ⁶⁴ Over the next several decades, public schooling expanded and nearly 80% of young people attended by 1870.65 In the meantime, no Confederate state reentered the Union after the American Civil War without adopting a state guarantee of education. 66 Modern constitutional democracies, such as Germany and South Africa, explicitly commit to the right to education.⁶⁷ In the twentieth century, the Supreme Court has repeatedly acknowledged constitutional dimensions of education: The government may not use race in assigning students to schools, ⁶⁸ and once a state provides education, it cannot exclude children who are not citizens if it provides schooling for those who are. 69 Concurring in one such decision, Justice Blackmun noted that "denial of an education is the analogue of denial of the right to vote: the former relegates the individual to second-class social status; the latter places him at a permanent political disadvantage."70

Nonetheless, over fifty years ago, the Supreme Court rejected constitutional claims for greater equality in resources and declined to discern a right to education. In *San Antonio Independent School*

District v. Rodriguez, five Justices rejected the challenge to the school finance system in Texas that produced twice as much perpupil expenditures in some communities as compared to others. And it did so while emphasizing the historic and ongoing importance of education to individuals and to society. Yet the Rodriguez opinion still left the door open to a constitutional claim when the government fails to provide each child with an opportunity to acquire the basic minimal skills necessary for the enjoyment of the rights of speech and of full participation in the political process. Despite this possibility, lower courts—perhaps anticipating views of the current Supreme Court Justices—effectively closed the door to federal remedies for such failures.

Following the Supreme Court, in two recent decisions, federal courts have rejected constitutional recognition of a basic right to education. The Despite devastating factual findings of falling ceilings, pest infestations, classrooms staffed by unqualified individuals, and reliance on obsolete texts, a recent effort from Detroit to find a right to education in the federal Constitution failed. So did a Rhode Island lawsuit to secure a right to civics education.

Litigation under state constitutions has led to notable remedies, but the U.S. Constitution is largely treated as a guarantee of "negative liberty"—that is, freedom from governmental restraints.⁷⁷

The distinction between negative and positive liberties in the eyes of many, including me, does not seem coherent. 78 For example, to ensure procedural protections against arbitrary governmental deprivations of life, liberty, or property, the government has to provide affirmative structures that cost resources. 79 Is it so different to ensure the educational predicate for elections and jury service? Concerns that courts are not well equipped to adjudicate the scope of a right to education are belied by historical and comparative examples. 80 Courts can play a critical role in convening other actors, such as legislators and executive leaders, to develop plans of action that fall within their competencies; courts also can set up procedures for community members to engage with governmental officials in designing steps and experiments.81 A step-by-step, evolving approach is precisely how the South African Constitutional Court has developed and filled in the right to education under its nation's constitution.82

Future federal litigation in the United States could assert and persuade a different Supreme Court to acknowledge a federal constitutional right to education. Even the current Court might be responsive to arguments framed in the historical, "originalist" terms that a majority of its members prefer. 83

Meanwhile, federal constitutional arguments for education matters hold significance in quarters other than the U.S. Supreme

Court. State courts and legislatures iteratively articulate and enforce education rights under state constitutions at the prompting of advocates and in dialogue with the government and other participants. Legislative efforts by public officials, including legislators, who swear an oath to uphold and implement the U.S. Constitution can be guided by constitutional arguments. So can voters, students, and parents. Effective social movements in America have repeatedly deployed the language of constitutional rights to help empower individuals and communities. Ust as mass efforts have advanced self-government and individual rights in movements for labor rights, civil rights, and rights to vote and to marry who you love, educational opportunity could motivate and

mobilize legislation and judicial action for educational opportunities.⁸⁹

Education matters for constitutional democracy because the structural elements of the Constitution alone cannot guard against voters falling under the sway of demagogues. For that, a society needs a populace, as Thomas Jefferson put it, educated to "enable every man to judge for himself what will secure or endanger his freedom." Education can and must equip each new generation to engage in the acts of self-governance, to respect the rights of others and the demands of political participation, and to act with vigilance to preserve and strengthen constitutional democracy.

These are not just nice-to-haves. A society that fails at a minimum to seek respect for each person as a worthy participant engenders resentment and instability. The same goes for persistent chasms between people's expressed wishes and actual governance. As Richard Kahlenberg and Clifford Janey put it, schools should "instill a love of liberal democracy: a respect for the separation of powers, for a free press and free religious exercise, and for the rights of political minorities. In this way, demagogues who sought to undermine those institutions would themselves be suspect among voters." No one can mandate freedom from anger, hatred, prejudice, or self-aggrandizement, but experiences and opportunities to learn can support conditions for forbearance, acceptance, and cooperation. Efforts to cultivate commitment to democracy could include a year of universal national service for people in their late

teens as recommended by the American Academy of Arts and Sciences commission on public purpose. 94

Strikingly, founders of this nation expressed very similar concerns not long after the launching of the nation. John Jay—then Secretary of Foreign Affairs under the Articles of Confederation—wrote George Washington the year before the Constitutional Convention about his concern for a lack of foundational commitments to the values of liberty, independence, and self-governance: "[W]e are yet to become a great and respectable People." John Jay continued.

What I most fear is, that the better kind of People—(by which I mean the People who are orderly and industrious, who are content with their situations and not uneasy in their Circumstances,) will be led by the Insecurity of Property, the Loss of Confidence in their Rulers, & the Want of public Faith & rectitude, to consider the Charms of Liberty as imaginary and delusive. ⁹⁶

George Washington, who returned to his plantation in Virginia after eight years of war, wrote back to Jay: "I am told that even respectable characters speak of a monarchical form of government without horror.... What a triumph for the advocates of despotism to find that we are incapable of governing ourselves, and that systems founded on the basis of equal liberty are merely ideal & fallacious!" ⁹⁷

Self-government works only if people take up the responsibility to participate and give the time and energy to inform themselves, to vote, and to hold officials accountable. Even an educated and rights-respecting populace cannot make a constitutional democracy work if the people cannot locate and receive reliable information and competing opinions about what government is doing and proposing, candidates for office, the conduct of powerful players, and the needs of neighbors. The digital revolution opens both promise and jeopardy, content and noise, by giving access to all of human knowledge but also to misinformation and disinformation and materials circulating freely without vetting. The task of education for discernment is urgent and essential if constitutional democracy is to survive.

II. NEWS AND INFORMATION

I suggest that the second fundamental prerequisite for constitutional democracy is access to reliable news and information. The U.S. Constitution provides explicit protection for only one private industry: the press. ⁹⁸ The Constitution also empowered Congress to create a postal service. ⁹⁹ The early Congress joined the two elements by establishing discounted postal rates for newspapers and the free exchange of newspapers between news printers and publishers. ¹⁰⁰ A scholar observed in a comparative study of speech in constitutional democracies, "A free press is obviously essential to democratic self-government. After all, how can citizens cast well-informed ballots on election day in the absence of truthful and accurate information about the pressing public policy issues of the day?" ¹⁰¹

Yet there have been economic and technological assaults on the sustainability, independence, and vigor of private media. A related

threat is the amplification of misinformation and disinformation, especially as propelled through digital communications. False or misleading information distributed online, through broadcasts, or cable—whether shared with or without intention to mislead and deceive—can jeopardize the health, safety, and well-being of individuals and pave the way to destabilize society and disrupt democracy. Repeated studies show that those communities lacking local news experience lower voter turnout and other political participation as well as higher levels of public and private corruption. 103

History offers insights into the sources and significance of the central importance of news access to democracy. As printed media became integral to British and American societies, ideas about freedom, popular governance, and resisting tyranny circulated through independent and competing outlets. ¹⁰⁴ Journalists employed by news media investigated the conduct of governments, businesses, and communities. ¹⁰⁵ Those medias long depended on a combination of subscriptions and advertising revenues. ¹⁰⁶

Digital communications businesses disrupted these sources of funding. Docial media platforms enable people to post and receive information without paying subscriptions and to share journalists' copyrighted materials without paying for their use. Audiences for conventional media have largely dwindled over the past decade. Willingness to pay subscriptions for printed media has dissipated. Advertising funds are reallocated from print, broadcast, and cable communications to digital media. The phenomenon is global. As ads migrate to digital platforms, the traditional media turns often to those very platforms to distribute their content—and big tech companies take a large share of ad revenues. These declines are especially notable and accelerating in local news. Recent reports indicate that even the term "news desert" is inadequate to describe the problem, because local news is disappearing across the

United States.¹¹⁴ Legacy media entities are shrinking or closing: Newspapers across the country have shut down at a rate of two-and-a-half newspapers per week, and nearly two-thirds of American journalists have lost their jobs within the last twenty years.¹¹⁵ Illinois alone has lost 86 percent of its newspaper jobs since 2005.¹¹⁶ Even heralded innovations, such as nonprofit digital news groups, face severe economic challenges.¹¹⁷

More than a decade ago, the Federal Communications Commission identified these trends as well as the dangers of misinformation and disinformation in a report on the information needs of communities. That report largely resisted governmental support assistance, yet in the face of accelerating negative trends, its lead author Steven Waldman now advocates for a variety of governmental support efforts. Recently, veteran journalist Sewell Chan assessed that effort as "timid and constricted," with a "hands-off

approach to media policy."¹²⁰ Billionaires who purchase media outlets may offer some shelter from the financial forces but often choose cuts when faced with financial losses. ¹²¹ Hence, the behavior of wealthy and consolidating owners may in fact contribute to the massive layoffs of journalists and downward spiral of the media industry. ¹²²

Strong local journalism strengthens voting, assessment of political candidates, and public benefits such as trust and reduced public and private corruption. When journalism shrinks, corruption increases and voting declines. Weakness in local journalism hurts democracy. Active journalism, in contrast, correlates with reduced toxic emissions, lower hospital admissions due to food poisoning, effective criminal justice reforms, and higher return on community bonds. Information changes behavior. The duties of self-governing citizens include understanding the issues of the day and assessing

options in response.¹²⁶ In the past, media helped communities develop a common identity, while balkanized media reflects and amplifies polarization and tribalism.¹²⁷ News organizations not only reflect but also help give form to a "public," a community of shared interests.¹²⁸ Journalists, in effect, invite people to identify with a community and also stand in for the polity in holding those in power accountable.¹²⁹ When the press loses its viability—when it disappears or when trust in it fades—social trust and the sense of participation in a shared community also dissipate.

It is sobering that Donald Trump, both as a presidential candidate and while in office, attacked the media and threatened to suppress the press.¹³⁰ He has pursued multiple lawsuits against media for defamation and banned the Associated Press from the Oval Office, press conference space at the White House, and Air Force One after the Associated Press declined to change its designation of a geographic space—known as the "Gulf of Mexico"—to the "Gulf of America," the name preferred by the President.¹³¹

Responding to earlier verbal attacks on media, Senator John McCain, Republican candidate for the presidency of the United States a few cycles ago, told the host of a news broadcast, "I hate the press. I hate you especially." He continued:

But the fact is we need you. We need a free press. We must have it. It's vital. If you want to preserve—I'm very serious now—if you want to preserve democracy as we know it, you have to have a free and many times adversarial press.... And without it, I am afraid that we would lose so much of our individual liberties over time. That's how dictators get started. 133

Who will stand up for the media? Media leaders may not do so themselves when their owners fear retribution by the administration. Having other business interests beyond media, media companies include conglomerates, like Disney (the owner of the American Broadcasting Company, or ABC), and are often owned by wealthy individuals, such as Jeff Bezos (the owner of the Washington Post and largest shareholder of Amazon). When Donald Trump became president-elect, ABC settled the defamation lawsuit he had brought against it; after Trump's election to serve a second term, Washington Post owner Bezos announced and enforced new editorial policies to promote free markets and personal liberties while stifling criticism in the Washington Post of Bezos himself. 135

What reforms can be framed that do not reduce the independence of journalism, do not increase industry consolidation, and do not benefit financial investors who buy into media only to strip it for parts? Could public and private investments strengthen avenues for new forms of journalism and new journalists—even if unbundled from conventional media outlets and distribution systems? Philanthropy, nonprofit newsrooms, and other forms of support can assist the development of powerful news stories and journalism appealing to diverse audiences. Public contributions, ranging from tax credits and deductions to investments in public media and resources for journalism, are also possible reforms.

Constitutional objections greet reform proposals calling for public revenues and government involvement. Such objections are overstated and contrary to longstanding federal and state involvement in financing and structuring the media ecosystem. A variety of public actions in the United States have tried to strengthen, change, and support accurate news sources. Amendment in the U.S. Constitution prohibits Congress from making any law that [abridges] the freedom of speech, or of the press. Amendment absolutism—as named by media studies scholar Victor Pickard—may seem to bar any governmental action financing or even affecting media organizations.

This is a false view. Look at how Congress in 1792 exercised authority specified in the Constitution to create a postal service—it authorized the free exchange of newspapers among printers and publishers while discounting the rates for delivering newspapers to all other readers. 143 State and local governments subsidized newspapers, and later communications technologies, with tax exemptions. The federal government invested in the first telegraph line and later established the licensing system for broadcasting with only nominal fees. Courts have shielded newspapers from a state tax targeting the press and from antitrust threats to the Associated Press, the cooperative service allowing outlets to pool some of the costs of newsgathering in order to enlarge and improve journalism and media. And the federal government has subsidized the development of radio, television, cable, communications satellites, internet, and public media on radio, television, and the web. 144 Vigilance against government suppression of speech is crucial and can be ensured by insulating editorial and content choices from government support and regulation. Collective efforts may be crucial to redress anticompetitive behavior, historic lack of racial and economic diversity in communications media, and the longstanding lack of attention to many communities. 145

Promising developments include investments by philanthropic donors in existing and new journalism—a coalition of philanthropies has promised more than \$500 million. His is private action, but governmental tax treatment for both donors and recipient entities amplifies it. Local groups in some cases have repurchased media outlets once bought by large chains or private equity. For-profit but financially strapped journalism efforts can convert to nonprofit status and diversify revenue sources. Sovernments can suspend antitrust rules to allow news outlets to collectively bargain for better terms with tech platforms. State and federal governments can use antitrust tools to prevent big entities from purchasing and essentially strip-mining local journalism. Direct local, state, and national government support can offer tax credits and incentives for investment in subscriptions and other support for journalism.

State governments can make direct investments in journalism despite federal inaction, and "digital first" models can reduce production and distribution costs for journalism. ¹⁵² Such measures are not only compatible with but also advance constitutional democracy by strengthening its preconditions.

President James Madison, a crucial Framer of the U.S. Constitution, once said, "a popular Government, without popular information, or the means of acquiring it, is but a Prologue to a Farce or a Tragedy." A farce or a tragedy is coming without fresh constitutional interpretations and inventive public and private policies.

III. GUARDING AGAINST LETHAL VIOLENCE

Farce or tragedy could describe the approach to lethal violence—notably intensified by the treatment of firearms—in the United States. A third crucial ingredient for a constitutional democracy is physical security and grounds for public confidence that social arrangements, including government, guarantee it. In contrast, the United States experiences the glorification of violence in media, including video games, which seems to match consumption patterns and desires of Americans in ways that differ from people in other nations. ¹⁵⁴ The very public shooting of a health insurance executive

in December 2024 elicited support for the shooter in expressing frustration with health insurance practices. ¹⁵⁵ Some speculate gun violence in America is influenced by public policies—including the militarization of police departments, mass incarceration practices, military practices in foreign policy—and frontier mentality. ¹⁵⁶

Whether you find that plausible or dubious, it is hard to deny that guns play a major role in the cultural attitudes and actual rates of lethal violence in the United States. Mass production and sale of multi-shot, revolving guns made lethal violence easy ever since the nineteenth century. ¹⁵⁷ Currently, America has the weakest gun laws of any rich nation, along with the most guns—more than 393 million according to Aaron Karp, a political scientist who tracks global distribution of small arms. ¹⁵⁸ Two other scholars state the situation

this way: Americans are twenty-five times more likely to be killed in a gun homicide than people in other high-income countries. Homicides and suicides using guns keep rising. Death by guns among American young people rose 50 percent between 2019 and 2021. Homicide is the leading cause of youth gun deaths; suicide accounted for about a third of the child and teen gun deaths during that time. The availability of guns is an undeniable factor in the increasing levels of gun deaths. That is a distinguishing feature of the United States and so are the levels of gun violence when the United States is compared with other societies. 164

During 2024, eighty-three school shooting incidents took place in the United States. 165 Live shooter drills are familiar features of school calendars, even for preschoolers. After a shooter in 2018 killed seventeen students and staff in a Parkland, Florida school,

students mobilized the "March for Our Lives." ¹⁶⁶ Over one million people marched and advocated for state and federal reforms. ¹⁶⁷ Twenty-six states then adopted laws meant to reduce gun violence. ¹⁶⁸ State law reforms have included higher minimum ages for gun purchases and longer waiting periods, but Congress enacted no federal laws in response to the movement. ¹⁶⁹ Federal inaction persists despite strong majorities supporting gun regulations. At work is the lobbying and campaign contributions of gun lobbyists, led by the National Rifle Association, and asserted barriers to regulation due to recent judicial interpretations of the Second Amendment. ¹⁷⁰

Partisan polarization in the United States contributes to federal inaction but only indirectly, because a majority of voters in both parties support gun control, including limits on what kinds of guns can be sold and to whom they can be sold. ¹⁷¹ The overrepresentation of small states in the Senate and gerrymandering of electoral districts for the house—producing more extreme candidates—may be to blame. Despite 92 percent of Americans favoring background checks before any gun sale, Congress has not enacted such a requirement. ¹⁷² For many years, Congress instituted a restriction on

funding for studies of gun-related violence which itself reflected the power of the gun lobby. ¹⁷³ Suspension of that restriction was the one federal congressional compromise after the mass shooting in Parkland, Florida. ¹⁷⁴ In 2022, President Biden and Congress accomplished what many had tried for decades—they succeeded in expanding background checks by signing into law the Bipartisan Safer Communities Act. ¹⁷⁵ This law broadened the category of gun sellers required to become licensed dealers and run background checks, though some serious loopholes remain. ¹⁷⁶

What do gun violence and related reform debates have to do with constitutional democracy? Majorities in the country support gun control laws, but even successful efforts to pass laws restricting access to and use of extraordinarily lethal guns face largely successful judicial challenges. The robust public desire for reasonable public safety restrictions on the sale and use of guns does not result in enforceable policies. In the United States, nearly 90 percent of those surveyed, expressed serious concerns about gun violence. Most accidental gun deaths of children actually occur in their homes or homes of friends. Physical safety and security matter in every

society; so does confidence that today's children will grow to adulthood. Self-governance may be impossible in an environment of fear and doubt about the future. ¹⁸⁰

Even when the majority desires gun safety rules, judicial interpretations of the Second Amendment reject reforms adopted by state and federal elected officials and chill further reforms. These interpretations—erecting an individual right to bear arms—are actually quite recent, supported by gun industry lobbyists and campaign contributors, and emerged from litigation campaigns by interest groups that succeeded in overturning longstanding judicial precedents departing from expert scholarship. 181 The text itself is ambiguous because the Second Amendment locates the right to bear arms in conjunction with the need for a militia. It reads: "A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed." To find an individual right to own and use guns in this language required some creative thinking and vigorous lobbying. The current judicial interpretation of the Second Amendment also ignores a scholarly debate over whether slavery influenced adoption of the Amendment, as some historians assert that an armed militia was needed to keep enslaved people from escaping, 183 though others disagree. 184

Not until 2008—217 years the after enactment of the Second Amendment—did five of the Justices announce, over a dissent by four other Justices, that the Second Amendment guarantees individuals the right to "bear arms," and in that light, rejected a ban on handguns adopted within the District of Columbia. Two years later, again in a five-to-four decision, the Court extended this decision to apply to state and local restrictions (thereby treating the

newly recognized right as one incorporated through the Fourteenth Amendment). ¹⁸⁶ Litigation challenging limits on individual ownership and possession of arms is now a growth industry. The trends cast grave suspicion about any state or federal regulations, as gun rights seems to foreclose reforms sought by majorities across the country. ¹⁸⁷

Despite initial predictions that the "individual right" approach to the Second Amendment would not produce upheaval in settled law, the Court in 2022, by a vote of six to three, struck down a New York law limiting permission to carry a concealed gun to the discretion of local law enforcement personnel. ¹⁸⁸ The majority, including three Justices appointed by President Trump, treated the right to carry a weapon as fundamental. ¹⁸⁹ Justice Thomas's opinion for the majority announced a constitutional presumption against gun restrictions, with exceptions solely when the government can "justify its regulation by demonstrating that it is consistent with the Nation's historical tradition of firearm regulation." ¹⁹⁰

The Court's analysis in this case, *New York State Rifle & Pistol Ass'n v. Bruen*, cast doubt on laws restricting privately made "ghost guns," on devices converting ordinary guns into machine guns, on gun bans applied to people subject to a domestic violence restraining order, and on restrictions of gun possession by people convicted of drug-related crimes.¹⁹¹ None of these neatly fit historic,

longstanding restrictions which now appear to be the criterion imposed under the Second Amendment. As judges try to implement the *Bruen* inquiry into "history and tradition," how should they address unprecedented technologies and at what level of generality? "Ghost guns," made without serial numbers, are now easily producible because of the arrival and prevalence of 3D printing. ¹⁹²

Neither 3D printing nor domestic violence restraining orders existed at the time of the Second Amendment's adoption. This fact influenced the federal court of appeals that struck down the legal restriction. When Congress enacted a restriction on gun possession by someone subject to a domestic violence restraining order, it looked not to the past but instead to contemporary research showing that armed domestic abusers pose a significant risk to intimate partners, law enforcement, and others. Such considerations fall outside the inquiry specified by the Supreme Court in challenges to restrictions on guns.

The Supreme Court underscored and compounded confusion in its 2024 treatment of a federal law banning gun ownership by individuals subject to certain domestic violence restraining orders. ¹⁹⁷ Eight

of the nine Justices upheld that law in *United States v. Rahimi*, but the matter generated seven opinions, six endorsing for the result and one (Justice Thomas, author of the prior *Bruen* decision) in dissent. Its seven opinions exposed continuing disagreement among the Justices over the meaning and scope of the Court's newly announced "history and tradition" test. ¹⁹⁸ Indeed, there appears to be some "buyers' remorse" by the five others who signed onto Justice Thomas's opinion in *Bruen*. ¹⁹⁹

The Justices differed over whether principles inferred from past regulations can satisfy what "history and tradition" allow instead of demanding a matching regulation from the past; they also differed over what time period and sources were relevant for discerning past traditions, and whether evolving societal needs can be taken into account. ²⁰⁰ Justice Jackson's concurring opinion pointed to examples of conflicting opinions emerging as courts try to apply the *Bruen* test and marked stark contrast with the nearly universal accord in the courts prior to *Bruen*. ²⁰¹ One retired judge from Texas, originally appointed by President George W. Bush, objected that judges "are not experts in what white, wealthy, and male property owners thought about firearms regulation in 1791." ²⁰² The Supreme Court's

opinions contribute to serious questions about the constitutional system, producing judicial confusion, instability for the public, and potential paralysis for lawmakers. Only a minority of the Court thought it relevant to consider evidence showing the heightened dangers that armed domestic violence offenders pose to their families, law enforcement, and their communities. On the constitutional system.

The repercussions of the Court's Second Amendment decisions reverberate and dislodge seemingly settled laws. The high court of Massachusetts recently relied on the Supreme Court's cases to strike down a sixty-seven-year-old ban on switchblades.²⁰⁵ A federal

judge in California reversed his previous ruling and struck down a one-hundred-year-old state ban on billy club weapons. ²⁰⁶ The Court of Appeals of North Carolina rejected the application of a long-standing law prohibiting possession of a firearm on educational property. ²⁰⁷

Some places are so sensitive that they deserve protection from the presence of guns, but which places count?²⁰⁸ The Supreme Court Justices seem certain that their own courthouse is one of those places.²⁰⁹ What about schools, houses of worship, sports gatherings, and neighborhoods where gun violence has been much higher than elsewhere? Perhaps like people communing over a Ouija board,²¹⁰ the judiciary seems to huddle over the mystery of Second Amendment interpretation while declining responsibility for decisions about what measures government can take amid the epidemic of gun deaths.²¹¹

Confusion over the interpretation of the Second Amendment also invites tensions between the federal and state governments. The Hawaii Supreme Court disagreed with the federal Supreme Court in what one observer described as "open rebellion" against the right to armed self-defense. Missouri tried to disregard federal gun control laws, but the Supreme Court sided with the federal government's laws. The dynamic could well change with a new set of federal lawyers involved.

Public opinion polls continue to indicate strong support for reforms framed in terms of responsibilities and security, not just rights, and for gun safety and restrictions applied to particular individuals such as persons with mental illness, people under the age of twenty-one, and people subject to domestic violence orders. The distance between majority views and adopted policies persists in many areas, with gun regulation serving as just one prominent example. That gap, coupled with crises of daily security,

illustrates a real danger to people's confidence in the government and in society. The gap emerges from structural elements set up by the U.S. Constitution and by accidents of history. Putting together the effects of the Electoral College and the Senate structure, a President who did not secure the popular vote can select judges and Justices who in turn can be confirmed by senators who represent a minority of voters even when the judicial nominations are opposed by senators who represent the majority. A constitutional democracy could create balance between federal and state power to help the expression of contrasting positions, to find a path between stability and change, and to guard against fraud in elections without creating insuperable obstacles to translating popular views into governmental policy. These approaches do not

characterize the current combination of constitutional structure and particular judicial decisions in the United States.²²⁰

A government's unresponsiveness to majority views on just one issue does not necessarily undermine people's perceptions of legitimacy across the board. But persistent distance from what people want and what the government delivers can generate distrust and, for some, make authoritarian regimes look more attractive. ²²¹ In the contemporary United States, the distance between popular desires seems to grow not only with regard to gun safety but other policies as well. ²²² The jeopardy to security arises, then, not only in the specific context of guns, but in the risk of disrespect and disobedience toward the government and the social order it represents. ²²³ Declining public confidence in governmental processes raises the risk of politically motivated violence. ²²⁴ In addition, disaffection and cynicism undermine participation critical to democratic governance. ²²⁵

After studying young people living in inner cities in the United States, Professor Monica Bell described "catastrophic violence," including gun violence and economic violence; she observed that "safety is a positive precondition for individual and collective freedom, perhaps especially for those to whom it has been long denied."226 Judge J. Harvie Wilkinson recently put the point powerfully in his opinion for the Fourth Circuit, sitting en banc as it upheld Maryland's ban on assault weapons. 227 That opinion observed that assault weapons "are not our forebears' arms, and these are not our forebears' calamities."228 Further, his opinion for the court reasoned that decades of legislated regulations demonstrated that the Second Amendment "has not disabled the ability of representative democracy to respond to an urgent public safety crisis. To disregard this tradition today—when mass slaughters multiply and the innovation of weaponry proceeds apace—could imperil both the perception and reality of well-being in our nation."229

Courts have important roles to play in preserving respect for constitutional text and continuity with history while also remaining mindful of the effects of judicial actions in the present and the future. A constitutional democracy is meant to serve a nation's

people.²³¹ In the specific context of the regulation of firearms, courts in a constitutional democracy can protect those who associate gun ownership and possession with security without suppressing sensible efforts to prevent and control gun-related suicides, mass shootings, and escalation of interpersonal and political conflict into lethal violence.²³² A judicial process that obstructs sensible, demonstrably effective safety laws governing guns not only puts communities in jeopardy, it also endangers the viability of a constitutional democracy.²³³

The risk of lethal violence and the contested treatment of gun issues are tied to broader dilemmas that courts alone cannot resolve. In the United States, race-related fears and actions are intertwined with patterns of gun-related violence. Racial disparities characterize police responses in the United States. Gun-related deaths for white Americans significantly involve suicide while for Black Americans, homicides vastly outnumber suicides involving guns. Fear held by some white Americans of being "replaced" by racial minorities seems to be connected with two recent mass-shooting incidents. Compared with gun owners who

are white, Black and Hispanic gun owners report a much lower sense of safety if more people could legally carry guns.²³⁸

Fears and distrust of others underlie the ideas of a social contract and a democratic constitution; people surrender a portion of their liberty in order to establish governments offering protection and enforcement of rights. Yet fear and distrust of others—sometimes triggered by terrifying incidents and sometimes by alarmist media can undermine the project of peaceful coexistence and self-government. 239 Self-defense, not hunting, has become the primary reason offered by Americans who buy guns; that itself exposes the high level of interpersonal and intergroup fear jeopardizing security.²⁴⁰ Rising levels of distrust of other people and of government indicate serious obstacles for solving problems and for a constitutional democracy.²⁴¹ Building bases for trust and replenishing lost trust may be pivotal to the security that a constitutional democracy is meant to provide. Creating and replenishing the conditions for security should be part and parcel of the project of a constitutional democracy.242 Reforms matter not only for the lives that could be saved but also for the legitimacy and effectiveness of self-government in the United States. Rather than aligning inputs and outputs into virtual circles of freedom and equality, our governmental system prevents the basic investments in ensuring its survival.

CONCLUSION

While this Article's discussion concludes here, the issues remain. No society is born a constitutional democracy. In ancient Greece and Rome, and in the United States for most of its first century, an

anti-democratic caste system prevailed.²⁴³ Even those nations committed to constitutional democracy must continually work on realizing those ideals. Democracies around the world face severe challenges, and the United States is far from immune. Indeed, as I have suggested, some of the ingredients necessary for the system to work are not only missing but are blocked by features of the system, whether by design or by happenstance.²⁴⁴

There are potential intersections between the three preconditions I have discussed.²⁴⁵ The lack of safety from gun violence has a specific impact on schools and education, creating an unsafe and oftentimes traumatic learning environment for schoolchildren, from active shooter drills—not to mention actual lethal violence in schools.²⁴⁶ Violent threats against journalists and restrictions on teaching civics in schools reflect some of the same dynamics of political polarization animating the legislative and judicial conflicts over regulating arms.²⁴⁷

Beyond the three I have addressed, anyone who cares about a viable democracy should spend more time on furthering basic predicates including: (1) acceptance of elections and sufficient reciprocity for peaceful transitions following elections; (2) peaceful co-existence and inclusive political deliberations among people with different affiliations and views; (3) adequate capacity and stability for families and other groups to provide care for children and the elderly; (4) freedom to form and maintain private associations, religions, and organizations; (5) a genuine promise to eliminate permanent castes and support a sense of "we" who share the polity and the opportunities of self-governance; and (6) effective vigilance against the forces that would prevent self-governance and rights for all. Sufficient grounds to believe that the political and economic systems are not

so rigged as to prevent lawful change may be a thread across all of these elements.

I am sure you can identify other preconditions. A sustainable, unpolluted environment with lands that are habitable and air and water to support life? Viable mechanisms for resolving disputes and for enforcing laws? These are essential for any functioning society under any system of government. Perhaps democracy's preconditions involve a Bill of Obligations, including the duty to reject violence in the face of political disagreement.²⁴⁹ Steps to cultivate a culture of commitment to democracy and to communities, exemplified by a mandatory year of universal national service for people in their late teens, could be a vital ingredient. ²⁵⁰ Mechanisms to protect equal conditions and improve the effectiveness of voting and representation by enlarging the House of Representatives, enacting ranked-choice voting, establishing independent commissions to draw voting district lines, and enacting limits on campaign contributions seem critical to many who are concerned with antimajoritarian features of the U.S. Constitution.²⁵¹

Those anti-majoritarian elements of the U.S. Constitution may make the United States particularly vulnerable to seizure by extremists. Failures in education, media, and safety destroy the preconditions for bridging divides that demagogues seek to create and exploit. Education opens people up to experiences and worldviews beyond their own. Without the shared understanding of reality created by access to reliable information, people lack the information relevant to setting priorities and meaningfully engaging with others. Profound fears about physical safety created by gun violence interfere with the trust and mental space to think, all demanded by democratic participation. Without education, reliable news, or a sense of safety, how can the people check the powerful and govern themselves?

Reforming these features would take mass movements for a new constitution—and it is not clear to me that the result would be a democratic one. I have focused on education, sustainable and trustworthy news sources, and fulfilling the majority's desire for public safety in a nation awash in guns. Democracy does not involve simply voting; constitutional democracy is not merely the written or unwritten principles. Those who have recently fought hard for constitutional democracy have much to teach those of us who simply inherited a version of it. Consider the insights of Cyril Ramaphosa, once a freedom fighter against Apartheid in South Africa and now its president: "Democracy therefore does not merely consist of the achievement of popular access to all important centres of power, and [the] complementary guarantee of certain fundamental rights. It consists also of social mechanisms, institutions[,] and forces which reinforce and deepen the formal processes of democracy." 255

William Hastie, a civil rights advocate and, later, federal judge, once explained, "Democracy is a process, not a static condition. It is becoming rather than being. It can be easily lost, but never is fully won. Its essence is eternal struggle."²⁵⁶ That struggle cannot be confined to political parties or elections. It also must involve people in pursuing the public good as they see it.²⁵⁷ Discussion of preconditions for constitutional democracy is an invitation to participate in that struggle.
